*Dismantling Of The Stands	02 rd – 03 rd July 2023 Dismantling and vacation of stands shall only be allowed on the designated date. *Opening Time	The opening time for exhibitors at the site is 08H00. This is to allow enough time to prepare the stands before the public and opening time and for the public is 9H00
*Closing Time	The Exhibition Tents shall close at 18H30. All other activities shall end at 23H30; the gates shall close at 00H00.
*Entrance Fee	Adults N\$10.00 per entrance, Vehicles @N\$20.00 Children N\$5.00 per entrance , Schools N\$200.00 (Maximum of 50 Learners)
*Extras	Name Badge: Only two per stand, if exhibitors are more than that, a cost of N\$200 per person should be paid for the duration of the expo.

- 7. No exhibitor will be allowed to sleep at the expo site.
