*Closing Time	Corporate section closes 20H00 Kiddies section closes at 22H00 while Entertainment sections closes at 02H00 (The timing may vary in accordance with the liquor license regulations) NB: Once the sections is closed the public will not be allowed to enter the closed section.
*Entrance Fee	Adults N\$10.00 per entrance, Vehicles @N\$20.00 Children N\$5.00 per entrance , Schools N\$200.00 (Maximum of 50 Learners)
*Extras	Name Badge: Only two per stand, if exhibitors are more than that, a cost of N\$300 per person should be paid for the duration of the expo.
